# VISAS

## Short-Stay vs. Long-Stay Visas

If you're from the UK or a non-EU country, you'll need a visa for stays over 90 days.

The long-stay visa (VLS-TS) allows you to stay for a year and must be validated within three months of arrival.



## Residency Permits (Carte de Séjour)

After your first year, you must apply for a carte de séjour at the prefecture.

Different permits exist for retirees, employees, self-employed individuals, and business owners.

## French Language Requirement

Some visas require proof of basic French (A1 level).

Learning French before moving will help with daily interactions and administration.

# OFFICIAL TRANSLATION SERVICE

In France, many administrative procedures, such as applying for a visa or registering a civil partnership, require official documents like birth certificates or driving licences.

If these documents are not in French, they may need to be translated to be accepted by the authorities.

In such cases, the translation must be done by a traducteur agréé (also known as a traducteur assermenté or traducteur expert), a translator officially recognised by the French legal system.

Only translations completed by these certified professionals are considered valid for administrative purposes.

## Support with the Language

If French is not your first language or you find it difficult to make appointments on the phone or in person, we can assist. If you haven't found a doctor, dentist, or bank, then let us help you find an English-speaking service, where available, in your area that you can feel confident accessing. For local appointments, our bilingual associate can be there to help interpret to ensure important information is understood.

## French Healthcare (Assurance Maladie)



### Registering for French Healthcare

After residing in France for three consecutive months, you are eligible to apply for state healthcare through the Carte Vitale system. This system typically reimburses around 70% of standard healthcare costs.

Many residents opt for complementary private health insurance, known as a "mutuelle" to cover the remaining healthcare expenses not reimbursed by Assurance Maladie. This additional coverage can significantly reduce out-of-pocket costs.

### Doctors and Pharmacies

When visiting a doctor, patients generally pay upfront for the consultation. Assurance Maladie reimburses approximately 70% of the standard consultation fee, with the remaining balance potentially covered by your mutuelle or paid out-of-pocket.

Pharmacies are widely available throughout France. The state partially reimburses the cost of prescription medications, with the remaining amount often covered by your mutuelle, depending on your specific insurance plan.

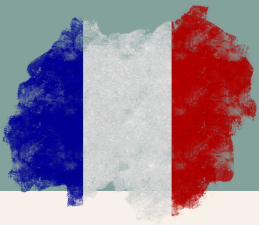

# DRIVING IN FRANCE

## Exchanging Your UK Driving Licence

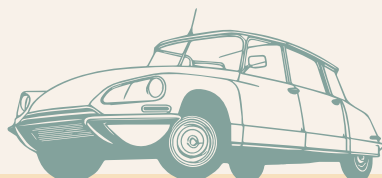
As of January 1, 2021, following Brexit, UK driving licences are recognised in France for short visits. However, if you become a resident in France, you are required to exchange your UK licence for a French one. The process involves submitting an online application to the French authorities and providing necessary documentation, such as proof of identity, residency, and your current UK licence.



# DRIVING IN FRANCE

## Essential Tips for Driving in France

- **Speed Limits:** Under normal conditions, the standard speed limit on French motorways (autoroutes) is 130 km/h. This is reduced to 110 km/h in wet weather and 50 km/h in heavy fog or icy conditions.
- **Toll Roads:** Many French motorways are toll roads. Be prepared to pay tolls either in cash or by credit card.
- **Priority to the Right:** At intersections without traffic signs, vehicles approaching from the right have priority. This "priorité à droite" rule is unique and may differ from UK driving norms.
- **Safety Equipment:** Carrying a warning triangle and a high-visibility vest in your vehicle is mandatory. In the event of a breakdown, you must wear the vest and place the triangle at a safe distance behind your vehicle to warn other drivers.
- **Mobile Phone Use:** Using a handheld mobile phone while driving is strictly prohibited and subject to fines.



- **Driving in Cities:** Some cities in France have implemented limited traffic zones (LTZ), restricting motorised vehicles without valid reasons for entry. This measure aims to improve air quality and reduce congestion. If you plan to drive in these cities, ensure you know these restrictions to avoid fines. To find\_out more [click HERE](#).
- **Roundabouts:** When approaching a roundabout, vehicles already circulating have the right of way. Yield to traffic coming from your left unless otherwise indicated.
- **Alcohol Limits:** The legal blood alcohol limit in France is lower than in the UK. It's 0.05% for most drivers, and for bus and coach drivers, it's 0.02%. Always ensure you're within the legal limits to maintain safety and compliance.
- **Seat Belts:** Wearing seat belts is compulsory for all passengers in front and rear.

Adjusting to these regulations will ensure a smooth and safe driving experience in France. Always stay updated on local laws and customs, as they can evolve over time.

# ARCHITECTURAL AND PLANNING SERVICES

If you're planning renovations or construction in France, you'll almost certainly need planning permission for the work you intend to do.

Planning permission is required for projects such as installing a Velux window in the roof, replacing old windows with double-glazed ones, adding a kitchen extension, transforming a barn into a living space, or even installing a swimming pool in your garden.

The zoning plan for your property (PLU) will indicate what is permitted and what is not. Restrictions may apply if your house is located in a historic area (e.g., near a church) or in an agricultural zone.

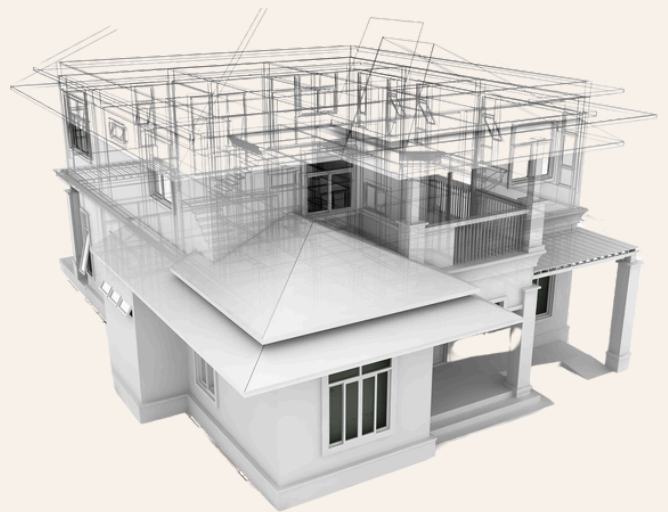
Depending on the work you intend to carry out, you will need either a DP (Déclaration Préalable) or a PC (Permis de Construire).

Additionally, if your home has more than 150 m<sup>2</sup> of habitable space, you will need to submit the plans to a French-registered architect.

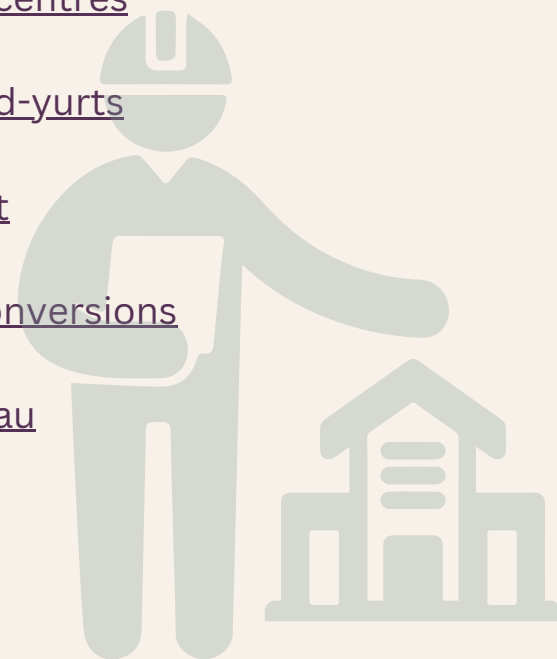
